**IRS Report-**All set to report thanks to Ruth Ann's annual insistence for many years that the Museum does have Federal Tax ID, This year we were able to contact representative at IRS that did check the number Ruth Ann had and confirmed it is correct and should have been valid for post card reporting in the past – which never

worked for us when we made the attempt. The IRS re-input the number plus additional information from us and we will be recognized in the data base in 6 weeks from that conversation at which time we will file on line the required post card and answer the 8 questions. Les had also found an article in a magazine which had the same information which we were getting on-line.

Annual Personal Information to Wisconsin Historical Society: Ruth Ann and Patsy file a required report on-line with the Madison WHS which includes all officers names, titles, home addresses, home telephone numbers and home e-mail addresses.
